3. Representations and Warranties:

I, the undersigned, hereby represent and warrant that:

- a. I am the sole owner of all rights in the submitted film OR I am duly authorised by the rightful owner(s) to submit the film for consideration for The Nigeria Prize for Creative Arts.
- b. The submission of the film to the Prize does not infringe upon or violate any copyright, trademark, moral right, contractual obligation, or any other right of any third party.
- c. All image rights, music rights, archival footage rights, and any other intellectual property incorporated in the film have been lawfully cleared and authorised for use.
- d. All required appearance or content releases, consents, and permissions for or from individuals appearing in the film or in respect of disclosure of any personal data contained therein have been duly obtained.

4. Prize's Rules and Decisions:

I acknowledge that I have read and understood the rules and regulations of The Nigeria Prize for Creative Arts and I agree to be bound by them.

I further agree that all decisions made by the judges and the Administrators are final and binding and not subject to appeal.

5. Promotional Use Authorisation:

If the film is selected, I hereby grant the Administrators the non-exclusive, royalty-free right to use excerpts, still images, trailers, and related promotional material from the film solely for Prize-related publicity, marketing, archival, and promotional purposes, including but not limited to print, broadcast, online, and social media



platforms.

6. Care of Materials and Limitation of Liability:

The Administrators agree to make reasonable efforts to handle and safeguard all submitted materials.

However, I acknowledge that the Prize, the Administrators or the Sponsor shall not be held liable for any loss or damage (whether direct, indirect or consequential) pertaining to, arising from or connected with, or technical failure affecting the submitted film or materials.

I hereby waive any right to initiate legal claims against the Prize, the Administrators, the Sponsor or judges arising from or connected to the submission, selection, exhibition, or non-selection of the documentary film.

7. Indemnity:

I agree to indemnify and hold harmless the Prize, the Administrators, the Sponsor and judges from any and all claims, damages, losses, liabilities, costs, and expenses (including legal fees) arising from this Agreement or any breach of the representations and warranties contained herein.

8. Governing Law & Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the Federal Republic of Nigeria.

The courts of the Federal Republic of Nigeria shall be vested with exclusive jurisdiction to determine all claims, matters and proceedings relating to, arising from or connected with this Agreement.

If any part of this Agreement is deemed unenforceable, same shall be severable and shall not affect the validity of the remainder of this Agreement which shall remain fully operative and enforceable in accordance with its terms.
